# The Levitt Network Event Safety and Security Training Management Plan April – November 2024









#### Overview

#### Aim

The aim of the Levitt network grantee team capability and professional development program is to deliver a structured program, underpinned by a series of risk management, event safety and security, command, control and communications (C3) modules. The program is designed to enhance the capability and resilience of the Levitt network's teams to adverse events in today's volatile and uncertain world.

#### **Objectives**

- To enhance Levitt teams' knowledge of industry-based standards and principles for event safety and security, for a risk-based approach to planning safe and secure events in an inclusive environment at Levitt venues and concert sites
- To enhance Levitt network event planners' decision-making and ability to communicate effectively with various stakeholders during adverse events and emergencies



#### Phase I. Spring Training Series: 16 April – 11 June 2024

- 16 April: Introduction to Event Risk Management Fundamentals and data-driven approaches to managing risk: Includes best practices for incident reporting and assessing near misses
- 30 April: Enhancing Your Team's Security Awareness: Risk mitigation through situational awareness and de-escalation techniques for disorderly guests
- 14 May: Staying Ahead of the Storm Front: Planning principles for developing and enhancing concert evacuation plans and severe weather decision matrix
- 28 May: Developing your Event C3 (Command, Control, and Communication) Plan: Internal and public communications, escalation protocols, and decision-making under uncertainty

#### 3.0 2024 Training Program Summary of Activities

#### Phase 1: Spring & Fall Training Series (8 x modules)

- April 16: Session #1 Introduction to Event Risk Management Fundamentals

- May 28: Session #4 Developing your event C3

#### 4.1 Phase 2 AAR 'Quick Wins'

AAR 'quick wins' recommendations were provided to FOLs and AMP grantees during the onsite visit program (informally) and as part of the post site visit AAR. Quick wins provided the opportunity for FOL's and AMP grantees to adopt/implement suggested event safety and security enhancements for their concert series which were pragmatic solutions which could be implemented relatively easily with limited impact on budget and staff time.

#### A summary of quick wins are:

- 1) Explore opportunities for first aid/'stop the bleed' training with local Fire & EMS.
- 2) Conduct all team pre-concert safety and security brief (template provided).
- 3) Add lids with 'donation' slots for donation buckets for additional security.
- 4) Create WhatsApp or text message groups to connect with vendors and other production stakeholders to enhance communications (both routine and emergency) prior to and during the concert.
- 5) Procure/supply 'high vis', branded t-shirts or vest to easily identify event staff and security.
- 6) ED or MC to conduct pre-concert brief, deliver a pre-scripted messages on house rules and event safety protocols.







#### 4.1 Phase 2 AAR 'Quick Wins' (cont.)

- 7) Conduct crowd counting utilizing volunteers and clickers (known arrival routes) to enhance accuracy of crowd size estimates.
- 8) Explore opportunities for first aid/'stop the bleed' training with local Fire & EMS Dept. and /or consider external opportunities for training.







#### 4.2 Phase 2 AAR Near Horizon Recommendations

Long-term recommendations that may require an incremental approach over time:

- 1) Consider procurement of radios to enhance event team communications.
- Develop event C3 matrix radio allocation by assigned role, location/space and call sign.
- 3) Implement process / procedure for incident reporting
- 4) Develop concert communications and escalation procedure for event safety & security related incidents.
- 5) 'Memorialize' institutional memory and knowledge into actionable checklists for event incident/emergency response procedures.
- 6) Transition existing 'text based' prohibited items signs to bi-lingual, pictogram signage.
- 7) Continue to deliver first aid and CPR training for all staff and volunteers and explore training opportunities for 'stop the bleed' training with local Fire & EMS Dept.
- 8) Develop deeper relationships with local public safety authorities and law enforcement.







#### 4.2 Phase 2 AAR Near Horizon Recommendations (cont.)

- 9) Continue to review and discuss risks and issues in a team setting, document and migrate risks into an event risk register.
- 10) Develop event safety risk mitigation plans for top 10 risks (FOLs) refer Levitt network 'toolkit' templates.
- 11) Consider implementing a volunteer leadership development program to identify and train designated volunteers for leadership roles.
- 12) Consider budgeting and procurement of AED and stop the bleed kits.
- 13) Review terms and conditions (T&C) for concert entry and aligned with signage to ensure policies for T&Cs policies (code of conduct) are clearly communicated to all guests / attendees on both the website and on-venue signage.


