Special Provisions:

- This offer will expire at 5p.m. EST on Thursday, November 14, 2024. Purchaser reserves the right to withdraw offer at any time.
- In the event this engagement is cancelled upon rule, regulation, order or recommendation of any state, federal or local government agency or by Purchaser in response to any public health threat or national pandemic such as the outbreak of a highly communicable disease, the Agreement between PURCHASER and ARTIST may be cancelled by Purchaser on written notice to ARTIST without further liability on either party.
- This engagement is at an outdoor venue that is free to the public with no admission charged.
- Artist acknowledges the Performance is open to the public and is presented in a family environment, therefore Artist must agree to use language appropriate for such an environment and acknowledges that the use of profanity during the Performance is strictly prohibited.
